1 Briefly describe the organization's mission: The mission of Special Olympics Michigan (SOMI) is to provide year-round sports training and athletic competition in a variety of Olympic-type sports for all children and adults with intellectual disabilities. Athletes are given continuing opportunities to develop physical fitness and athletic skill, demonstrate courage, experience joy and participate in a sharing of gifts, skills, friendship with their families, other Special Olympics athletes, and the community.

4a (Code:) (Expenses \$ 5,122,616 including grants of \$) (Revenue \$) Special Olympics Michigan provides year-round programs for over 27,745 children and adults with intellectual disabilities and Unified Partners (athletes without intellectual disabilities). Through sport, athletes experience inclusion, unity, dignity, respect, joy and friendship. They develop physically and socially; gain confidence, and build a positive self-image which carries over into the home, classroom, job and community. Young Athletes™ programs for 2 to 7 year-olds are offered to introduce children and their families to the world of sports. There are 2,315 children participating in Young Athlete programs throughout the state. The SOMI program relies on contributions of time, materials and funds from donors and volunteers.

4b (Code:) (Expenses \$ 78,706 including grants of \$) (Revenue \$) Healthy Athletes® programs provide free health screenings to athletes. Over 3,000 athletes participated in health screenings for vision, dental, physicals, feet, hearing, and health promotions. Healthy Athletes® screenings are held at state events for vision, hearing, dental, foot care, physical therapy, and health physicals at no cost to athletes or their families. These screenings educate athletes on healthy lifestyle choices and identify problems that may need additional follow-up.

4c (Code:) (Expenses \$ 801,538 including grants of \$) (Revenue \$) Special Olympics Unified Champion Schools bring together students with and without intellectual disabilities through education, sports and youth leadership to provide them with the knowledge, attitudes and skill necessary to create and sustain school communities that promote acceptance, respect and human dignity. There are currently 280 Special Olympics Unified Champion Schools in the state of Michigan. Spread the Word to End the Word rallies, anti-bullying programs, and Unified Sports are some of the main opportunities offered by this program. Unified Sports® provide youth with and without intellectual disabilities the opportunity to train and play together as teammates. Students develop fitness and athletic skills while forming friendships, fostering respect for each other, and becoming leaders on and off the court. SOMI offers unified opportunities in soccer, softball, basketball, golf, cycling, flag football, kayaking, bocce, track, snowshoe, skiing, snowboard, figure skating and bowling involving a combination of 11,130 Unified Partners and Special Olympics Michigan athletes.

(SOMI) is organized into 37 geographical, local, sub-accredited programs for athletes to train and compete in or near their home communities. Athletes can choose from 24 sports including alpine skiing, athletics, basketball, bocce, bowling, cross-country skiing, cycling, figure skating, golf, gymnastics (artistic and rhythmic), horseshoes, poly hockey, power lifting, soccer, snowboarding, snowshoeing, softball, speed skating, volleyball, flag football, kayaking, and weightlifting. SOMI also offers a Motor Activities Training Program designed for individuals with severe and profound disabilities, or who do not yet possess the physical or behavioral skills needed to participate in official Special Olympics sports. All programs are offered at no cost to athletes and their families. Athlete training is an integral part of the program and athletes train at least eight weeks prior to a competition. SOMI offers athlete leadership opportunities such as global messenger training which teaches public speaking skills. In addition, athletes can participate in state-level competitions. SOMI offers 6 state-level and 716 regional and area-level competitions each year. The largest event is the State Summer Games with 4,130 participants. State Fall Games combines soccer, softball, cycling, flag football, kayaking and golf with a total of 1,686 athletes. Other events include four District Basketball events with 1,496 athletes; State Unified Basketball with 420 athletes; State Basketball Finals with 722 athletes; State Winter Games with 1,354 athletes; State Poly Hockey and Unified Bowling with 1,215 athletes. SOMI is a volunteer-driven organization with 32,867 volunteers throughout Michigan. Volunteers serve as coaches, chaperones, state and area event volunteers, Area Directors, and Area Management Team members. Area programs offer sports training and competition within a geographic location under the guidelines and direction of SOMI. Two annual leadership conferences are held to conduct training in leadership skills necessary to run a local program and share best practices. Coaches are required to become certified in the sport they coach. SOMI provides coach training programs for all sports offered. SOMI receives a significant amount of donated services and facilities that help run the program in a cost effective manner. In 2017, the value of professional services and facilities donated totaled \$882,523. SOMI publishes several monthly electronic newsletters with more than 28,000 subscribers, maintains a website at www.somi.org, a YouTube page, as well as social media accounts on Facebook, Twitter, Instagram, and Snapchat. Other publications on SOMI programs are available by calling 800-644-6404.
